

Enrolment Application Fee

There is a \$30.00 enrolment application fee charged per application lodged.

Family Enrolment Deposit

If you are successful in enrolling at Our Lady of Good Counsel School, you will be required to pay an Enrolment Deposit of \$200.00 per family. This is to be forwarded to the school office within one working week from acceptance in order to hold the position for your child. This deposit will then be deducted from your annual tuition statement

Building Levy

Families are subject to a compulsory Building Levy of \$520 annually. If there is only 1 child enrolled at the school and they are in Kindergarten, this levy is discounted to \$313. Pre-Kindergarten students are exempt from this charge.

Account Payment

An annual fee statement is issued to families in early February each year. Families must select a payment plan from the 4 options provided, to ensure that fees are settled in full by the end of October each year.

Withdrawal

A full terms written notice must be provided to the school when advising of a students withdrawal. Failure to provide this notice will result in the payment of a full terms fees.

Financial Assistance

A fee discount is available for holders of a valid Concession Card. Families should contact the Finance Manager with their concession card to discuss eligibility. This discount is not applicable to Pre-Kindy.

Family Discount

A family discount applies to the number of students undertaking schooling at OLGC at the same time. The discount is applied in order of age, with the eldest student receiving the lowest discount. The discount does not apply to Pre-Kindergarten students. The discount is applied as a percentage of the Tuition Fee, Class Resource Fee and IT Levy ONLY as per the below table:

1 st Child	Full Fee
2 nd child	20%
3 rd child	40%
4 th child (or more)	100%
